

LIST OF BY-LAWS FOR 2002

**BY-LAW #'S**

- 1954 To stop up and close part of the Original Shore Road Allowance in front of Lot 4, Concession 1.
- 1955 To amend By-law No. 1284.
- 1956 To amend By-law No. 1908.
- 1957 To establish the salary and wage rates for non-unionized employees.
- 1958 To establish a remuneration to members of Council.
- 1959 To establish the salary and wage rates or part-time non-unionized employees.
- 1960 To provide for interim tax rates for the year 2002.
- 1961 To authorize the signing of a lease between the Township and Canada Post Corp.
- 1962 To appoint members to the committee of adjustment.
- 1963 Relating to terms and conditions of a financial contribution to assist with replacement of the roofing membrane and the installation of dehumidifier at the East Ferris Community Centre.
- 1964 To regulate smoking in municipal buildings and municipal workplaces.
- 1965 To authorize the execution of an agreement between the Nosbonsing Curling Club and the Township of East Ferris in pursuance to the short forms of Leases act relating to the lease of a curling facility.
- 1966 To set tax ratios for the Township of East Ferris municipal purposes for the year 2002.
- 1967 To stop-up and close part of the unopened road allowance between Lots 24 and 25, Concession 1.
- 1968 To stop-up and close part of the unopened road allowance between Lots 19 and 20, Concession 4.
- 1969 To stop-up and close part of the unopened road allowance located in Lot 7, Concession 15.
- 1970 To authorize the execution of development agreement between Decking & Siding Ltd. and the Township of East Ferris.
- 1971 To establish a percentage by which tax decreases are limited for 2002.
- 1972 To adopt the estimates of all sums required for general purposes during the year and to provide for the adoption of tax rates for 2002.
- 1973 Providing for the erection of stop signs.
- 1974 To authorize the signing of an agreement between the Township of East Ferris and the Township of Chisholm.
- 1975 To amend By-law No. 1284 as amended.
- 1976 To amend By-law No. 1383 and to authorize a charge per household for the collection service.
- 1978 To authorize the signing of an agreement between the Township and The Northern Ontario Heritage Fund Corporation.
- 1979 To deem lots 3 & 4 on registered plan M-487 not to be lots on a registered plan of subdivision.
- 1980 To amend By-law No. 1284 as amended.
- 1981 To amend By-law No. 1284 as amended.
- 1982 To impose fees and charges for municipal services or activities.
- 1983 To settle fees for lottery licensing.
- 1984 To enter into an agreement with the Municipality of Callander for the enforcement of the Building Code Act and Site Plan Control Agreements.
- 1985 To Govern the proceedings of Council, the conducts of its members and the calling of meetings.
- 1986 To prescribe the form and manner and time for the provisions of notice required by the municipal act.
- 1987 To regulate the keeping and control of animals.
