5. PUBLIC HEARINGS:

Applicant: 1851477 Ontario Inc.

A public meeting was held on a zoning by-law amendment application submitted by 1851477 Ontario Inc. in order to facilitate the redevelopment of the subject property for commercial uses.

Mr. Degagne spoke to the application and advised the rezoning is required to allow for a potential medical centre in the future as well as additional commercial uses. Mr. Kirton advised no correspondence was received and he has no concerns. The rezoning will expand the scope of permitted uses of the property. Mr. Herauf asked whether there were any concerns with the land hosting a gas station in the past. Mr. Degagne has had a Phase II environmental study completed for the subject lands.
