CORPORATION OF THE TOWNSHIP OF EAST FERRIS

BY-LAW NO. 2218

BEING A BY-LAW TO ESTABLISH PROCEDURES FOR THE SALE OF REAL PROPERTY OWNED BY THE CORPORATION OF THE TOWNSHIP OF EAST FERRIS.

WHEREAS pursuant to Section 268 (1) of the Municipal Act, 2001, c.25 the municipality shall pass by-laws to establish procedures, including the giving of notice to the public, governing the sale of certain real property by the municipality;

AND WHEREAS Section 270 (1) (1) of the Municipal Act, 2001, c.25 requires the municipality to adopt and maintain policies with respect to the sale and other disposition of land in the municipality;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF EAST FERRIS ENACTS AS FOLLOWS:

- 1. That where made applicable by Section 268 of the Municipal Act, 2001, c. 25 this By-law shall apply to the sale of real property by the Corporation of the Township of East Ferris including a lease of 21 years or longer.
- 2. Notwithstanding Section 1, the following classes of land are exempt from this By-law:
 - (1) Land 0.3 metres or less in width acquired in connection with an approval or decision under the Planning Act;
 - (2) Sale of land under Part XI, Municipal Act, 2001 Tax Arrears;
 - (3) Closed highways if sold to an owner of land abutting the closed highway;
 - (4) Land formerly used for railway lines if sold to an owner of land abutting the former railway land;
 - (5) Land that does not have direct access to a highway if sold to the owner of the abutting land;
 - (6) Land repurchased by an owner in accordance with Section 42 of the Expropriations Act;
 - (7) Land sold under Sections 107, 108, 109 of the Municipal Act, 2001;
 - (8) Easements granted to public utilities or to the telephone companies; and
 - (9) The disposition of shoreline road allowances in the Township of East Ferris which shall be sold in accordance with the policies and procedures adopted by By-law No. 2195.
- **3.** Prior to the disposal of any property by the municipality, the Council of the Township of East Ferris shall by resolution declare the property to be surplus.
- 4. That prior to the disposal of real property and where there is no exemption under the regulations, the Council of the Township of East Ferris shall obtain at least one appraisal of the fair market value of the real property.
- **5.** That the form of appraisal shall be an "Opinion of Value" from a Realtor.
- 6. That the Council may direct by resolution that this appraisal shall be conducted by an independent qualified appraiser who is a registered member in good standing of the Appraisal Institute of Canada.
- 7. That notice to the public of the proposed sale shall be given at least 10 days, including holidays, prior to the disposal of real property by posting a notice on the subject property or at a nearby location chosen by the Township Clerk or his designate.
- 8. That the Council of the Township of East Ferris may direct by resolution that the notice to the public be given by publication in a newspaper having general circulation in the

municipality.

- **9.** That unsolicited offers to purchase real property may be processed on a first come first serve basis.
- 10. That when more than one party has expressed an interest in purchasing real property or where the Council believes it to be in the best interest of the community, the Council of the Township of East Ferris may by resolution direct that the real property be sold by tender.
- 11. That the purchaser shall be responsible for all costs incurred or required to dispose of the real property including legal, survey, appraisal, encumbrances, advertising, improvements, administrative fees and so on.
- 12. That where the real property is not to be disposed of by tender, the purchaser shall pay in advance, the appraisal costs and the cost of giving notice to the public.
- 13. The municipality shall establish and maintain a public register listing and describing the land owned by the municipality or local board and this register is attached hereto as Schedule "A" to this By-law. The following classes of land are exempt from the register:
 - (1) Land 0.3 metres or less in width acquired in connection with an approval or decision under the Planning Act;
 - (2) Lands acquired for road widening acquired in connection with an approval or decision under the Planning Act or for the reconstruction of highways;
 - (3) Highways; and
 - (4) Land formerly used for railway lines.
- **14.** The Minister of Municipal Affairs and Housing may make regulations:
 - (1) exempting the sale of prescribed classes of land from all or any of the provisions of this By-law;
 - (2) removing the requirement to obtain an appraisal of land that is being sold to a prescribed public body; and
 - (3) prescribing classes of land that are not required to be contained in the public register of land under this By-law.
- **15.** That By-law No. 1757 is hereby repealed.
- **16.** This By-law shall come into effect on the date it received third reading by the Council of the Corporation of the Township of East Ferris.
- 17. Each and every one of the provisions of this By-law is severable and if any provisions of this By-law should for any reason, be declared invalid by any Court, it is the intention and desire of Council that each and every one of the then remaining provisions hereof shall remain in full force and effect.
